Putting users before the product: PRISMA and EFET join forces to deliver the most efficient gas capacity booking

Brussels/Leipzig. PRISMA, the European gas capacity booking platform and its associated Transmission System Operators (TSOs) initiated at the end of 2014 the "Usability Project" whose core focus was to deliver an improved website tailored to its users' needs. PRISMA and its TSOs asked EFET, as a fundamental partner, to actively participate in this project.

PRISMA and EFET began cooperation in 2013, jointly developing standard trading conditions for the secondary market, EFET and PRISMA have now joined forces to deliver a better experience for users through the Usability Project. So far, results from the projects have surpassed initial expectations.

The workshops with the EFET users' group were important in gathering feedback and discussing the necessary functionalities of the Usability Project. To ensure the best results, the involved teams gathered feedback from a large number of users who were given the opportunity to validate improved content, new structures and process flows.

By conducting constant simulations, PRISMA and the EFET users' group created designs for key platform screens that are easy to use and understand yet still include all relevant technical information required to use the booking system. The new design better supports shippers in performing actions on the platform through its task oriented interface and improved display of the network points.

Despite significant changes in the design of the platform, users reported finding the system much more accessible. Most of the users that tested the new platform consider it much more intuitive to use and state that the new design will let them work more efficiently:

PRISMA European Capacity Platform GmbH was founded in January 2013, using the collective experience in capacity booking of major European TSOs. The company aims to facilitate the early implementation of the Network Code on Capacity Allocation Mechanisms (CAM) - the future European market rules for allocating transport capacity. The platform is designed to handle harmonised capacity products, offer auction mechanisms and serve different TSO backend systems in accordance with the CAM Network Code. Additionally, with its secondary functionality (launched 1 January 2014) European shippers can use the PRISMA platform to trade transport capacity on the secondary market.



PRISMA is a major step towards an integrated European gas market linking the markets of fifteen different countries in the core of Europe. It opens new possibilities for cross-border gas transport to shippers, who can book primary and trade secondary transport capacity at European network points through one single platform.

There are currently 35 European TSOs from Austria, Belgium, Czech Republic, Denmark, France, Germany, Ireland, Italy, Luxembourg, the Netherlands, Portugal, Slovenia, Slovakia, Spain and United Kingdom connected to the PRISMA platform.
